Photoshop, you can save the work as an image file. `_Image History_` is the place where Photoshop stores any image you save. You can also use Image History to roll back an image to a previous state. You may want to do this when you've made a mistake or done something wrong. To access and edit Image History, choose `Image⇒History`. (This is a one-step, direct, method of

accessing Image History.) The Image History dialog box opens. (See Figure 7-17.) FIGURE 7-17: See the history of the image you just saved. The number in the upper-right corner of the Image History dialog box shows how many versions of the image are available to choose from. The number of versions is based on the size of the file you're working on. If you're

why you should know it:
Starter Version If you are looking for a simple editing tool and you don't need features like advanced selections, gradients or many of the stock tools, Elements is for you. When you learn, you should start with the one that is easiest to understand and you can feel it is for you. If you are looking for something more complete and you can understand it well enough

to use it for a hobby,
Elements is not for you.

You should start with something more advanced that is simple enough to use and in which you can spend most of your time learning and not wasting time in features that are difficult for you to understand. Less Complex Elements is less advanced than Photoshop but you can use it for professional level tasks. It is simple to

use, but there are many options in the menus and basic features are simpler to use than their advanced counterparts. For example, you can crop a picture by going to select and crop from the gear menu and you can make basic edits that are easier for a beginner to do. Photoshop is complex and it is hard to get started without a crash course. There are more buttons and options than

you can use at the same time, so you cannot use Photoshop for professional-level work without help.

Faster If you are not a power user you will find it easy to use Elements. The performance is much better than Photoshop and you can do something fast even with a large picture.

Elements is quick, even when it performs very complicated tasks like manipulating many layers

or performing complex selections. Photoshop takes a lot longer to edit a picture when you are not trained to use it. Simple Elements is simple to use, but if you want to do complicated things it may be difficult to do. It is more like Paint than Photoshop and if you want to do a professional level of editing, you may not be able to do much more than simple edits. There are

many ways to do a task and Elements does not always give you the fastest way to do it. If you need something quicker than Elements, there are other options you can use. You should use one that has the features and the time to do something you want. Tools Elements has many more tools than Photoshop. There are many drawing, selection and special image tools that you will

not find in Photoshop.

PER CURIAM. 1 Ronald L.
Schelle appeals the district
court's¹ order dismissing
without prejudice Schelle's
complaint for failure to pay
the filing fee. We affirm. 2

The South Dakota Supreme Court suspended Schelle's license to practice law, and later disbarred him, for unethical conduct and commission of criminal offenses. In his complaint, Schelle alleged that a number of different types of misconduct and crimes were perpetrated by South Dakota's State Bar and its attorneys. A copy of the order disbaring Schelle was attached to Schelle's

complaint. Schelle also alleged that South Dakota's State Bar and the attorneys who have been assigned to perform his investigation are all impostors, claiming they are not allowed to practice law because they are not licensed. Although Schelle asked the court to name them and their predecessors as "trustees," he stated that the petitioners' names were

known to him. Schelle also requested that the court subpoena the administrators of South Dakota's legal education program and other counsel who appeared before the South Dakota Supreme Court. 3 The district court granted Schelle thirty days in which to pay the filing fee. Although Schelle requested that the court stay its order pending the outcome of certain

administrative proceedings in which he was involved, the district court determined that such proceedings were not related to Schelle's complaint and issued the order of dismissal. Schelle appeals. 4 First, the district court did not abuse its discretion in dismissing Schelle's complaint. See *Todd v. Weltman, Weinberg & Reis Co.*, 474 F.2d 473, 474 (8th Cir.

Atomic layer deposition (ALD) is a process used in semiconductor manufacturing for forming layers on substrates having features in the range of nanometers. In general, an ALD process involves introducing gases into a process chamber and chemically and physically reacting or decomposing those gases

at the surface of a substrate to form a layer of the appropriate thickness. The ALD process typically involves positioning the substrate on a wafer support in the process chamber and heating the substrate to a deposition temperature in the range of approximately 400° C. to 600° C. while flowing gas reactants across the substrate. The first reaction or decomposition

step, referred to as the nucleation or seeding step, includes adsorbing a reactive molecule onto the surface of the substrate. The deposited atoms then react with the reactive molecules from the gas phase. Next, the reactant molecules from the gas phase react with the adsorbed species and the deposited atoms form a continuous layer. Multiple cycles of the adsorption

and reaction steps enable film growth to occur. The ALD process enables precise thickness control of the deposited material and the avoidance of grain growth. ALD processes are generally performed at low pressure (e.g., 1-10 mtorr) and at low temperature (e.g., 400° C. to 600° C.) to limit the number of defects in the material. In some applications, ALD processes have been used

to form electrically insulating films on substrates. For example, ALD processes have been used to form silicon oxynitride films. One technique for forming silicon oxynitride films includes decomposing two or more different silicon-containing precursors to form a silicon oxynitride film on a substrate.
