The present invention relates to a work support mechanism for an apparatus for rolling paper. A conventional type of the apparatus for rolling paper, as shown in FIG. 3, comprises a frame body 1 with a rectangular support plate 2 mounted on its surface. The support plate 2 has four V-shaped grooves 3 formed thereon on a face 3a thereof. A working tool plate 4 is mounted on a support portion 1a of the frame body 1 and has a rectangular portion 4a with a plurality of teeth 5 formed thereon on a face 4a thereof. The working tool plate 4 is threadedly coupled to a head portion 1b of the frame body 1. In brief, the "Final Judgment" gives all parties one year to commence an action in the state court for the recovery of money or property, and it provides that "the plaintiff is entitled to recover his attorneys fees from the defendant." Thus, the "Final Judgment" would not allow an award of attorney's fees under the state declaratory judgment act.[2] Plaintiff has raised the other three arguments in support of this fee application: \*1068 (1) that defendants' defense of this lawsuit has been frivolous; (2) that defendants were motivated by a desire to harass plaintiff, thereby justifying the imposition of sanctions; and (3) that the other defendants are also liable for the attorney's fees and costs incurred by plaintiff in this case. These three additional arguments were briefly described in plaintiff's "Supplemental Memorandum in Support of Plaintiff's Motion for Award of Attorney's Fees and Costs," at p. 2, as follows: The First Amended Complaint charges that all of the defendants are liable for the amount of the plaintiff's judgment. At that time, the defendants contended that the plaintiff's judgment was fraudulent and should be set aside. One of the defendants was charged with obstruction of justice when he obtained the order to set aside the judgment on his own motion. All of the defendants are charged with a conspiracy to defraud plaintiff and deter her from collecting her money. In essence, the defendants have been charged with a conspiracy to deprive the plaintiff of her rights under the Constitution of the United States. Defendants have engaged in criminal activity, and they are not being prosecuted. The law is clear that defendants must be served and they must answer in the state court action. If defendants do not answer, a default judgment will be entered against them. The defendants, in presenting their motion to vacate the judgment, filed a declaration which contained a partial denial of all the allegations of the First Amended Complaint. Defendants made a motion for the order to strike the allegations of the First Amended Complaint which they contend pertain to these defendants who are not parties to this action. The California District Court of Appeals has ruled in plaintiff's favor on this motion. Defendants have presented an argument for the reversal of this decision. In view of this, plaintiff's position is that defendants' defense of this case has been frivolous, and that the other defendants are also liable for the amount of the attorney's fees and costs incurred by plaintiff in defending this action.
